

North Wales Technical Divers (NWTD)

Club Joining Instructions

1. Email scans of technical diving certification (see below), a scan of a head and shoulders photo like a passport photo (jpeg scan), mobile phone number, residential mailing address, emergency contact name, emergency contact mobile phone number and relationship to you.
2. Email scans of signed Member Agreement and Disclaimer (page 2 and 3 of Joining Instructions).
3. Once reply received from NWTD, either (a) join North Wales Technical Divers BSAC club/branch using BSAC's web site or, (b) if you are already a member of a BSAC club/branch contact BSAC membership and ask them to secondary affiliate you to NWTD or, (c) if you a direct member contact BSAC membership and ask them to affiliate you to NWTD.
4. Pay club fee (£25), email: proof of payment.
5. Wait to receive membership number.

Please note that processing of applications to join NWTD is subject to the availability of Branch Officers. Branch Officers are volunteers; this is not a full-time role therefore late applications may not be processed in time for the planned diving. **Therefore, we recommend providing all information required within the same email no less than two weeks prior to your planned diving date.**

To be eligible to join every member must hold a qualification that certifies them to conduct planned decompression dives to a depth of at least 40m utilising a suitable redundant breathing gas supply and experience of cold water diving demonstrated by a certification achieved in the UK or in similar conditions.

BSAC – Advanced Twin-set Diver, i.e., Twin-set Diver and ADP
BSAC – Dive Leader with signed off depth progression experience to 40m
CMAS – 3*
IANTD – Advanced Nitrox
PADI – Tec 40
PSAI – Advanced Nitrox
RAID – Deco 40
SSI – Extended Range Nitrox Diver
TDI – Decompression Procedures Diver

Member Agreement

I declare that I understand my obligations as a member as detailed below. Failure to comply with these obligations will void membership with immediate effect.

Member Obligations:-

- To be eligible to join every member must hold a qualification that certifies them to conduct planned decompression dives to a depth of at least 40m utilising a suitable redundant breathing gas supply and experience of cold water diving demonstrated by a certification achieved in the UK or in similar conditions.
- Each diving member shall be medically fit to dive.
- Diving members must not exceed their certification level or experience, e.g. maximum depth, gas mixes used, etc. Diving beyond certification limits is only permitted when participating in an authorised training course, refer to NWTD Training Policy.
- Diving must be planned and conducted with a buddy, solo diving is not permitted.
- All persons who assist with club/branch activities should become members of BSAC.
- The right to vote at the club/branch meeting shall be restricted to members who have a current membership. A membership has expired once passed the anniversary of their renewal.
- Comply with the rules for specific dive sites.
